Crazy Arrow Hunting Club By-laws

The following by-laws are designed so that all members, members' family and guest will have a safe and enjoyable hunting experience.

Updated by-Laws 2009-2010

1. Club managers are as follows: Billy Petree and Donnie Mears.
2. Membership description: One paid membership is to be deemed as one primary member. Primary member's direct family will be considered as secondary members. Secondary members shall consist of a spouse, son or daughter whom resides at the primary's resident up to 19 years of age. Game harvested by a secondary member will count as a part of the primary member's yearly state limit.
3. As of this time, the lease will consist of 12 primary members.
4. Club managers reserve the right to deny membership or revoke membership to any member or secondary member whom does not comply with the club by-laws or State hunting regulations. Members whom are expelled from club will forfeit all membership dues.
5. Membership dues amount shall be set by the club managers and must be paid in full by the 1st of each year. Members whom are late to pay dues and haven't made prior arrangements to the managers will forfeit membership.
6. Membership will be opened to anyone whom is 18 years of age or older and holds a Texas Hunting License. There will be a prospective members list and all primary members are encouraged to add names to the list. Available lease membership will be considered from the existing prospective list first.

7. One paid membership will be allowed the county bag limit of 2 bucks and 2 does per paid membership. This includes secondary members and guest deer totals.
8. This lease is primary a deer hunting lease but all game hunting is allowed and state hunting regulations will be adhered to. Beings this is primary a deer hunting lease, during deer season, deer hunters will have the first right to hunt an area over other types of game hunting.
9. No guest will be allowed to hunt until after the second weekend of the opening of deer season.
10. Only one guest per member will be allowed to hunt. Member must be present for guest to hunt.
11. Primary members will have stand choice over secondary members and guest.
12. Secondary members and guest shall comply with all club by-laws and state regulations and shall be the responsibility of the primary member.
13. Secondary members and guest 14 years of age or younger must hunt in the same stand with the primary member.
14. One hunting stand per member only. Members are allowed to have a lean ladder or climbing stand within there stand hunting area.
15. Members may hunt any stand on the lease as long as the primary owner is not hunting such stand.
16. Due to safety reasons, it is recommended that all permanent box blinds be constructed at least 4 feet off the ground. Temporary pop up blinds can be used in your hunting area only, but must be removed after your hunt is over. No permanent ground blinds are allowed.
17. All primary members, secondary members and guest whom are going to be in the field hunting, must sign in on the camp board, the stand location which they are hunting before there hunt begins. A member may also call one of the mangers or another primary member to write there name on the board, but it is the hunters responsibility to have his or her name on the board.
18. Members are responsible for keeping there feeders full and may feed all year if they wish.

19. Members must not disturb other members hunting areas. A member can hunt another member's box blind but can not erect a lean ladder, pop up blind, climber or do any tree trimming without full permission of the hunting areas member.
20. Members must keep the lease clean, leave no trash behind.
21. Members must keep the main gate entrance locked if locked, leave open if open.
