



## Insurance and Indemnification

Customer shall indemnify, defend and hold harmless La Tapatia Mexican Restaurant / The Martinez Event Center, its employees and volunteers against and from claims or suits for damages or injury arising out of or in any way related to Applicant's rental/use of La Tapatia Mexican Restaurant / Martinez Event Center and shall further indemnify and hold harmless La Tapatia Mexican Restaurant / The Martinez Event Center, its employees and volunteers against and from claims or suits for damages or injury arising out of or in any way related to such use, including but not limited to all costs, attorney's fees and costs of defense, expenses and liabilities related to any claim or action or proceeding brought within the scope of this indemnification clause.

All customers shall provide La Tapatia Mexican Restaurant / Martinez Event Center with a valid Certificate of Liability Insurance written through carriers acceptable to La Tapatia Mexican Restaurant / Martinez Event Center. Such certificate shall provide Bodily Injury and Property Damage Liability protection in the amount of \$1,000,000 per occurrence. If liquor is provided by the customer, a Liquor Liability is required. The Certificate of Insurance shall name La Tapatia Mexican Restaurant / Martinez Event Center, its employees and volunteers as the Additional Certificate in conformance with the Hold Harmless Agreement as outlined above and must specify that the applicant insurance shall be primary to any insurance carried by La Tapatia Mexican Restaurant / Martinez Event Center. The certificate shall be properly executed with an original signature of an authorized agent of the insurance company and is due one week prior to event.

NOTE: Please contact your insurance agent regarding whether or not your homeowner's policy may be extended to cover your event. If your insurance company does not cover this, you may purchase Special Event liability insurance for your event through Hub International Services. A processing fee may be charged for this service.

## Insurance Options

Add \$100 per hour room rate for customers providing their own liquor. Security will be provided at customer's expense.

### Option 1. HOMEOWNER'S POLICY-

- A) Contact your Homeowner's Insurance Agent (most will provide this service free)
- B) Request a Certificate of Insurance with Liquor Liability for your One Day Event (\$1,000,000)
- C) Add La Tapatia Mexican Restaurant / Martinez Event Center as Additional Insured to your homeowner's policy.

### Option 2. SPECIAL EVENT INSURANCE POLICY- (SEE ATTACHED FORM)

- B) Request a One Day Event Insurance Certificate (\$1,000,000) Liquor Liability included
