## APPLICATION FOR MEMBERSHIP & STATEMENT OF AGREEMENT

I (we) hereby apply for membership at Wild Quail Golf & Country Club and the resultant rights and privileges therein. This application will not be acted upon unless fully completed, signed, and accompanied by the initiation fee, if applicable. The classification of memberships, fixing the amount of dues payable by the members of each class, fixing the amount of initiation fees, the expulsion of members, and all other questions affecting or relating to members or membership shall be under the complete control of management at Wild Quail.

Any person of good character and at least 18 years of age is eligible for membership at Wild Quail. Membership will never be denied on the basis of race, creed, religion, or national origin, nor shall any aspect of which matters ever be made a condition of membership. Children between the ages of 5 and 17 may also become members with parental consent and parental financial liability.

This membership agreement indicated below is between Wild Quail Golf & Country Club ("the Club") and the undersigned member.

A: Wild Quail Golf & Country Club agrees:

1. That it shall provide an equipped Club facility which will include swimming pool, tennis court, a pro shop, lounge, and locker room facilities, subject to its right to terminate the facilities as described herein.
2. That the Member shall be entitled to all of the rights and privileges due a member in good standing under the Rules as they now exist and as they may from time-to-time be amended or supplemented.
3. In the event of a member's death or disability, said member or his estate may terminate his membership by providing to the Club objective evidence from a third party of such death or disability that is satisfactory to the Club, in which case the member's liability for dues shall terminate as of the date of such death or disability.

B: Member(s) understand and agree:

1. To authorize the disclosure and release of information to Wild Quail Golf & Country Club by those persons and entities named herein for the purpose of determining my (our) eligibility for membership.
2. That membership is contingent upon approval, which shall be in the Club's sole discretion. If approved, I (we) commit to a minimum membership term of one year. If for any reason my membership must be terminated prior to my one year commitment, I authorize Wild Quail to execute a credit card voucher in the amount of all unpaid charges as well as dues for the remainder of my commitment.
3. I understand my membership dues are subject to change, unless otherwise guaranteed.
4. To be bound by the Rules and Regulations of the Club as they now exist and as they may from time-to-time be amended or supplemented. That I (we) have received and read a copy of these Rules. I (we) further agree to waive all legal recourse against the Club for infractions of these rules and By-Laws during my membership.
5. ALL INITATION FEES ARE NON-REFUNDABLE
6. THAT ALL MEMBERSHIPS ARE NON-ASSESSABLE, NON-VOTING, NON-PROPRIETARY, NON-TRANSFERABLE unless by written approval of the Club and the payment of a transfer fee which is subject to change, and can be terminated at any time at the discretion of management, in which case a member's liability for future monthly dues shall cease.
7. **That resignation is accepted only after completion of the one year commitment being satisfied and requires an advance thirty- (30) day written notice to the Club.**
8. This Agreement does not grant any lifetime rights to the member. The Club reserves the right to terminate the use of its facilities or any part thereof by members after giving thirty days' notice.
9. This Agreement is assignable by the Club.
10. To render timely payment of all dues, fees and other such charges incurred or for which I (we) become obligated. I (we) also understand that I (we) are responsible for all charges that are billed unless disputed within 30 days of billing date. Charges that are more than 30 days old are not subject to dispute. Balances not paid within 30 days of billing may be charged to my VISA/MASTERCARD, DISCOVER OR AMERICAN EXPRESS (Please Circle One).
